## Price Discounting, \$15 Minimum Price Policy Passes in Minneapolis

Minneapolis continues to be a leader in adopting strong commercial tobacco prevention policies. The City Council voted unanimously to pass a comprehensive amendment to the city's tobacco ordinance on April 25, 2024.

The amendment prohibits price promotions and the redemption of coupons for all commercial tobacco and vaping products, sets a \$15 minimum price on cigarettes and chewing tobacco, increases penalties for retailers who violate the ordinance, and ends the sampling loophole for new tobacco products shops.

Saint Paul passed a similar, first-of-its-kind policy

in 2021. Now both of the Twin Cities have taken a stand against one of the tobacco industry's most predatory marketing tactics: price discounting.

One-third of adults who smoke regularly use tobacco coupons or discounts to buy commercial tobacco products, and the industry continues to send these coupons to keep folks coming back for more. Higher commercial tobacco prices lead to reduced adult smoking rates, less youth initiation, and more quit attempts and calls to quitlines. All that is bad news for the tobacco companies, so they use discounts to counter the high prices.

The ordinance changes will reduce the appeal of commercial tobacco products and support those who are trying to quit smoking or vaping. We applaud the Council for passing this ordinance and putting their residents' health above industry profits.

Thank you to everyone who emailed, called, testified, sent a letter of support, attended a council meeting, and spread the word about this ordinance. Your voice matters in creating important public health policy change!

## **Legislative Recap**

What Passed, What Didn't?

The Minnesota House and Senate wrapped up the 2024 legislative session on May 19. It was a busy year, and there was a lot of movement related to commercial tobacco and cannabis.



## Passed:

#### Moist Snuff Definition Changed

Legislators added 'or similar product containing nicotine' to the moist snuff definition in state law as an attempt to include new oral nicotine products with synthetic or derived nicotine. The change does not affect or change any tobacco product taxation or regulation.

#### **Deceptive Vapor Products Sale Prohibition**

This legislation prohibits marketing, promotion, advertisement, distribution, or sale of a vapor product that imitates any non-vapor product, including but not limited to food, school supplies, a product based on or depicting a character, personality, or celebrity, and/or a product intended to conceal the nature of the vapor product. These products are already illegal under federal law.

X Not Passed:

#### Flavored Commercial Tobacco Product Sales

While HF2177/SF2123 ultimately did not pass, the Minnesotans for a Smoke-Free Generation coalition made significant progress in advancing the bill this session. The bill made it through two successful House committee hearings and remained alive until the last weeks of session.

#### Flavored Cannabis Sales

The coalition worked with lawmakers to introduce language that would prohibit the sale of flavored cannabis that is burned, inhaled, or vaped. Lawmakers weakened the language in committee, and this amended language did not pass in the end.

## Faith Leaders Attend Mini-Day at the Capitol

The Minnesotans for a Smoke-Free Generation coalition continued to engage lawmakers faceto-face at the Capitol after the coalition-wide advocacy day in March.

Pastors and congregants from Black churches across the Metro and other faith community leaders visited the Capitol on April 18 to meet with lawmakers. They spoke with Senate President Bobby Joe Champion and other legislators to advocate against tobacco industry targeting in the Black community and urge them to support ending the sale of all flavored commercial tobacco products, including menthol, to protect Minnesotans of color. It was an impactful day.

## ANSR and Student Action Team Attend 2024 EPIC Youth Gathering

ANSR's Student Action Team and youth partners from Washington Technology Magnet School attended the 2024 E-Cigarette Prevention Initiative Cohort (EPIC) Youth Gathering on June 17 to wrap up a great year of commercial tobacco and vaping prevention advocacy. The full-day event at Radisson Blu Mall of America brought together 10 youth groups funded by Minnesota Department of Health's Youth E-Cigarette Prevention and Cessation Initiative grant.

Students met and connected with peers from across the state who are working on vaping prevention in their schools and local communities. They attended breakout sessions to write their own raps about commercial tobacco prevention and build their peer-to-peer education skills. They also learned about the legislative process, how nicotine affects the brain, and policy, systems, and environmental change, among other topics.

## **Donor Spotlight: Why I Support ANSR** Dr. Jean Forster



Dr. Jean Forster

Jean Forster, PhD, MPH, is professor emerita at the University of Minnesota School of Public Health and is Director at Large on the ANSR Board of Directors. She has been a board member since 1996.

While on the faculty at the School of Public Health, she conducted community-level policy intervention studies in tobacco control, alcohol, UV exposure, and health equity, particularly among the American Indian community.

Jean's commercial tobacco-related studies include the American Indian Community Tobacco Project, Clean Indoor Air Consequences, the MN Adolescent Community Cohort Study, Tobacco-Free Youth Recreation, Tobacco Policy Options for Prevention, and Tobacco Free Future. For

decades, she has helped underpin ANSR's cutting-edge policy, systems, and environmental (PSE) change work with peer-reviewed research and evaluation. Her contributions to the field of commercial tobacco prevention cannot be overstated.

When asked why she supports ANSR, Jean said: "ANSR's advocacy for smoke-free air and reducing youth tobacco use is incredibly effective. Thanks to ANSR's leadership we have some of the best state and local tobacco control policies in the country. ANSR is always breaking new ground."

## CounterTools Store Audits Complete

ANSR staff and partners completed nearly 450 CounterTools tobacco retailer audits in Ramsey, Hennepin, and Dakota Counties this spring. Data collectors visited stores and recorded data on product availability, minimum prices, and advertising to get a picture of the commercial tobacco sales landscape in the Metro area. The data will inform future point-ofsale policy work.

Groups across the state did similar assessments using funding from the JUUL settlement and administered by the Minnesota Department of Health. A big shoutout to everyone across the state who completed CounterTools assessments this year!
